



# GUEST CODE OF CONDUCT POLICY

In order to assist in our efforts to provide a fun, enjoyable, and safe experience for all customers, we have implemented the following *Guest Code of Conduct Policy*. We ask for your cooperation in following its terms. Your entry to The Amazing Pizza Machine constitutes your consent to comply with this policy.

1. Paid admission of a Buffet or Play Package is required for all guests age 3 and older.
2. Follow all posted safety signage for Games, Rides, and Attractions. Play is at your own risk.
3. Children 12 and under must be supervised by an adult at all times.
4. We are not responsible for lost, broken or stolen items.
5. Behavior that is disorderly, disruptive, or endangers others is prohibited.
6. Fighting, physical or verbal harassment or threats, shouting, offensive and other sexually explicit language, intimidating conduct, and provoking confrontations is prohibited.
7. The use of obscene language, obscene gestures, or racial, religious, or ethnic slurs is prohibited.
8. Defacing, damaging, or destroying any property is prohibited.
9. No loitering, running, skating, skateboarding, or other "horse play".
10. No littering. Discard items in provided waste bins.
11. Smoking, tobacco use, and e-cigarette use are not permitted inside or within 20 feet of the entrance.
12. Guests may not engage in any unlawful activity or behavior while on the premises.
13. The possession and/or use of any illegal drugs is prohibited. Violations will be reported to law enforcement.
14. No weapons of any kind, including firearms, may be brought onto the premises, with or without a permit.
15. Picketing, demonstrating, leafletting, distributing handbills or other information, petitioning, and/or soliciting is prohibited absent the prior written consent of Management.
16. Guests are not permitted in closed or unstaffed areas or in any unoccupied party room or dining room.
17. Except where the entire premises are rented for a private event, the premises, facilities, and/or party rooms may not be used for religious services, practices, worship, instruction, or prayer (except for the saying of grace or other similar prayer over food by individuals in a manner that does not disturb or interfere with other guests). This applies uniformly to all guests, regardless of religion.
18. Only animals trained to assist persons with disabilities are permitted in the building. Service animals should remain on a leash or in a harness and under the control of the owner at all times.
19. No outside food or drink (including alcohol) is allowed, except for birthday cakes or cupcakes.
20. In order to consume alcoholic beverages served at our establishment, you must be at least 21 years of age and present a state-approved identification card. No exceptions.
21. Be respectful of others. No cutting in front of other guests in any waiting lines including foodservice lines or any waiting line at our rides or attraction areas.
22. For food safety reasons, do not leave used plates, dishes, or glasses in the buffet court or foodservice areas. Leave them on your table or in designated bus cart stations.
23. While our buffet is "unlimited", no food may be taken away from the premises. Additionally, we ask that you plate the food you reasonably plan to eat, and then come get seconds and thirds, etc., if you would like more. This will ensure you get all you desire to eat and drink, without wasting food and beverage.
24. Only adults may consume beverages in the Amazing Arcade. Please no eating in Arcade areas.
25. Guests must be fully clothed (including shoes and shirts) at all times, and cannot wear indecent, inappropriate, excessively baggy, or gang-related attire. Clothing must adequately cover the body; visible undergarments are not permitted. Clothing with profanity and/or objectionable images is also prohibited, as are masks and hoods.
26. To assist us ensuring that this Code of Conduct is followed, security cameras are in use on the premises. Thus, your conduct in public spaces is viewable by Management.
27. We may photograph, film, record, or otherwise reproduce the image and/or voice of any person who enters the premises and use the same for any purpose, without payment to the person. Your entry onto the premises constitutes your consent to the same.
28. We reserve the right to refuse admission or service or bar from the premises anyone who fails to follow this Code of Conduct, and to require persons already admitted to leave the premises without refund, liability, or compensation, where violations occur. Other action deemed appropriate by Management may also be taken.
